FIRST ADDENDUM TO THE CONTRACT FOR DISSEMINATION AGENT SERVICES

This First Addendum to the Contract for Dissemination Agent Services (this "Addendum"), is made and entered into as of the 2ND day of September, 2021(the "Effective Date"), by and between Fishhawk IV Community Development District, a local unit of special purpose government established pursuant to Chapter 190, Florida Statutes, located in Hillsborough County, Florida (the "District"), and Rizzetta & Company, Inc., a Florida corporation (the "Consultant").

RECITALS

WHEREAS, the District and the Consultant entered into the Contract for Dissemination Agent Services dated October 1, 2016 (the "**Contract**"), incorporated by reference herein; and

WHEREAS, the District and the Consultant desire to amend the Fees section of the Contract; and

WHEREAS, the District and the Consultant each has the authority to execute this Addendum and to perform its obligations and duties hereunder, and each party has satisfied all conditions precedent to the execution of this Addendum so that this Addendum constitutes a legal and binding obligation of each party hereto.

NOW, THEREFORE, based upon good and valuable consideration and the mutual covenants of the parties, the receipt of which and sufficiency of which is hereby acknowledged, the District and the Consultant agree to the changes to amend the Fees to \$1,000 per annum for the Series 2013 Bonds.

The amended Fees are hereby ratified and confirmed. All other terms and conditions of the Contract remain in full force and effect.
